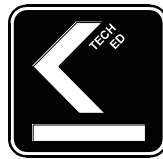

- 1.1. Candidates are advised to read the prospectus carefully.
- 1.2. This prospectus is subject to alteration(s) and modification(s) without any prior notice.
- 1.3. This prospectus is for information only and does not constitute a legal document.
- 1.4. Candidates who have passed the qualifying examination and desire to seek admission in Diploma level courses must register through the link on the counselling website "**www.punjabteched.com**" and "**www.punjabteched.net**" as per the counselling schedule.
- 1.5. The schedule of on-line counselling shall be notified through the Newspapers and also on the official websites of the Board "**www.punjabteched.com**" and "**www.punjabteched.net**". No separate intimation letters will be sent to candidates.
- 1.6. Any change in the schedule of admissions will be notified through press and on Board's websites.
- 1.7. Admissions will be made on the basis of inter-se merit of the qualifying examination, as per notifications and the **reservation** policy of the Government of Punjab and Chandigarh Administration.
- 1.8. Reservations of seats in the affiliated institutions in Punjab shall be as per the policy of Government of Punjab, and for the institutes located at Chandigarh the reservation shall be as per the policy of Chandigarh Administration.
- 1.9. The candidates desirous of claiming reservation under any category whatsoever are accordingly advised to get the requisite certificates issued well before the cut-off date, otherwise their certificate shall not be considered and their claim for reservation shall be summarily rejected. No extension shall be granted in this regard, under any circumstances.
- 1.10. Kindly refer the latest notifications /amendments issued by Government from time to time regarding Reservation of seats.
- 1.11. This prospectus is common for Admission in the institutions affiliated to the Board and located in the state of Punjab and Union Territory of Chandigarh.
- 1.12. The candidates having passed the matriculation exam from the schools located in UT(Chandigarh) are eligible for admission under 15% quota in the institutions located in Punjab State subject to fulfilment of eligibility criteria laid down by the Government.
- 1.13. Similarly, the candidates having passed matriculation exam from Punjab and other states can seek admission in the institutions located in Chandigarh under 15% quota, subject to fulfilment of eligibility criteria laid down by the UT Administration.
- 1.14. The candidate must give correct information in the Registration Form, and any information found incorrect or false at a subsequent stage shall render the student liable to expulsion from the institution.

## 4. ELIGIBILITY:

### 4.1 Eligibility for admission to Diploma in Engineering level courses

- a) The admission to the Diploma level Engineering Courses shall be through online counselling. Student should be passed 10th standard/SSC examination as prescribed by All India Council for Technical Education, New Delhi in the Approval Process Handbook 2023-24.
- b) Admission to Diploma Level Engineering courses shall be made on the basis of relative merit of qualifying examination mentioned above.
- c) A part from the above basic educational qualifications, the general eligibility criteria shall be as contained in Punjab Government, Department of Technical Education and Industrial Training, Chandigarh Notification No. TECH-TE-2013/1/2023-3TE2/365 Date 21-04-2023 available on Board's website.

### 4.2 Eligibility for admission to Diploma in Pharmacy

- a) Minimum qualification for admission to Two year Diploma Course in Pharmacy-  
 Shall be 10+2 examination(passed in science academic stream) with Physics, Chemistry and Biology or Mathematics.  
 OR  
 Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examination.
- b) Admission to the Two years Diploma course in Pharmacy shall be made on the basis of relative merit of the qualifying examination. Any other qualification

approved by the Pharmacy Council of India as equivalent to any of the above examination

- c) As per the decision of the PCI: candidates who have passed 10+2 from National/State Open Schools are also eligible for admission to diploma in Pharmacy.
- d) A part from the above basic educational qualifications, the general eligibility criteria shall be as contained in Punjab Government, Department of Technical Education and Industrial Training, Chandigarh Notification No. TECH-TE-2013/1/2023-3TE2/373 Date 21-04-2023 available on Board's website.

#### 4.3 Eligibility for admission to Diploma in Modern Office Practice

- a) All those candidates who have passed the 10+2 examination with or without Science from a board recognized or established by Central/ State Government through legislation shall be eligible to apply for Three Years Diploma in Modern Office Practice.
- b) Admission to Diploma in MOP course seats shall be made on the basis of relative merit of qualifying examination mentioned above.
- c) A part from the above basic educational qualifications, the general eligibility criteria shall be as contained in Punjab Government, Department of Technical Education and Industrial Training, Chandigarh Notification No. TECH-TE-2013/1/2023-3TE2/361 Date 21-04-2023 available on Board's website.

#### 4.4 Eligibility for admission to Admission in 2nd year of Diploma in Engineering level courses through Lateral Entry

- a) Candidates who have passed  
10+2 Examination with Physics/ Mathematics/ Chemistry/ Computer Science/ Electronics/ Information Technology/ Biology/ Informatics Practice/ **Government** Biotechnology/ Technical Vocational subject/ Agriculture/ Engineering Graphics/ Business Studies/ Entrepreneurship **(combination of subjects as mentioned by AICTE in APH 2023-24 as per the table 1.3(a) (copy at the last page of prospectus)**

**OR**

10<sup>th</sup> along with 2 years ITI shall be eligible for admission to Second Year Diploma Courses of in ANY branch of Engineering and Technology.

- b) It is further provided that seats remaining unfilled on the basis of eligibility criteria mentioned above shall be filled on the basis of inter-se-merit of any of the following examination:
  - I. 10+2 Vocational examination in various branches from a board recognized or established by Central /State Government through legislation.
  - II. Two years certificate course from Sant Longowal Institute of Engg. and Technology, Longowal.

- III. Two years certificate course in Skill Technician (Machinist), Skill Technician (Machine Maintenance) & Quality Insurance Inspector from R&D Centre for Bicycle & Sewing Machine, Ludhiana.
- IV. 3 Years AICTE approved Diploma in Engineering of any other branch from any recognized Board (As per Punjab Government. notification No. TECH-TE-2013/5/2021-4TE2/1061 dated 28-10-2021)
- c) Admission to LEET seats shall be made on the basis of relative merit in the qualifying examination mentioned above.
- d) A part from the above basic educational qualifications, the general eligibility criteria shall be as contained in Punjab Government, Department of Technical Education and Industrial Training, Chandigarh Notification No. TECH-TE-2013/1/2023-3TE2/369 Date 21-04-2023 available on Board's website

#### **4.5 Other Criteria:**

For the Academic session 2023-24, 85% seats shall be reserved for the candidates who belong to the State of Punjab and 15% shall be open to all candidates from outside Punjab, on all India basis.

The Eligibility criteria for 85% seats shall be for candidates who are resident of Punjab State as per Punjab Government, Department of Personnel and Administrative Reforms (PP-II Branch) letter No. 1/3/95-3PPII/9619 dated 6th June 1996 and letter No. 1/3/95-3PPII /80 dated 1<sup>st</sup> January, 1999 or shall have passed the qualifying examination from an institution/school affiliated to Punjab School Education Board/ CBSE/ ICSE/ National Open School situated in Punjab. The candidate would be required to submit a domicile certificate to this effect from the Principal/Head of Institution last attended in the prescribed Performa as given in the prospectus.

#### **5. ONLINE REGISTRATION**

1. It is mandatory for all candidates to register for participating in online counselling.
2. Registration Fee will be accepted through online mode of payment only.

#### **6. PROCEDURE FOR ON-LINE COUNSELLING**

Centre for Development of Advanced Computing (C-DAC), S.A.S. Nagar, Mohali has been entrusted with the task of conducting ON-LINE counselling for admissions. The procedure to be followed for ON-LINE counselling is as under.

#### **Objectives**

The Board has adopted ON-LINE OFF CAMPUS counselling with following objectives:

- a) To bring 100% transparency in seats allotment and admissions.
- b) To build strong public interface to minimize travel burdens on the students and their parents for counselling.
- c) To provide enough time to students for submission, change, delete, selection of multiple choices of courses/ institutes from anywhere anytime.



- d) To provide the required information, answers to queries, reports at different levels through the counselling website.
- e) To organize centralized database and centralized monitoring.
- f) To achieve Paper-Less counselling and reporting including fee submission.
- g) To make secured and controlled data access at every level.

### Strategies:

C-DAC has been entrusted to accomplish the task of Software development, testing and implementation of Web based ON-LINE OFF CAMPUS registration and counselling for admissions to all AICTE approved technical diploma level courses being run in all technical institutions in the State. To achieve the said objectives, a website shall be launched by Centre for Development of Advanced Computing (C-DAC), S.A.S. Nagar Mohali. The website shall entail all the information, procedures, instructions and guidelines for online counselling.

- i. Admissions shall be made through ON-LINE counselling by C-DAC, in collaboration with the Board. Detailed instructions for online admission procedure will also be available on Board's websites [www.punjabteched.net](http://www.punjabteched.net) and [www.punjabteched.com](http://www.punjabteched.com).
- ii. To participate in ON-LINE counselling, it shall be mandatory for every candidate to register through Board's website as per schedule available on the website.
- iii. The candidates who participate successfully in the counselling will be required to exercise their initial choices of branches and Institutes through Internet from places of the inconvenience or the designated polytechnics.
- iv. The procedure for exercising choices or seeking other information is simple and menu driven on the counselling website. It shall guide the candidates by appropriate messages on the computer screen.
- v. The candidates, who would like to upgrade their earlier allotted seat in the 1st round of counselling, are also permitted to participate in the subsequent round of counselling. In such cases, if candidate is allotted a seat in subsequent counselling's, then his/her allotment of seat of previous round shall stand automatically cancelled and the candidate shall not have any claim what so ever on the previous allotment.
- vi. The admission of the candidates shall be confirmed by institute only after payment of admission fee and verification of the uploaded documents. PSBTE &IT
- vii. After the issuance of Provisional Allotment letter, all the students will get the original documents/certificates verified at the allotted Institute on the day of reporting at the Institute as per counselling schedule.

Candidates must bring the following certificates while reporting to the institute:

#### 1. **Original Certificates:**

- Qualifying Examination Detail Marks Sheet
- Matriculation Certificates (Date of Birth)

- Character Certificate from institutions last attended
  - Proof of Residence/Domicile Certificate
  - Certificate in support of claim under reserved category.
  - Income Certificate, if admitted under Tuition Fee waiver seat/Reserved Category in support of claim under reserved category.
  - PM Care Certificate (wherever applicable)
  - Equivalency Certificate (wherever applicable)
2. Attested copies of above certificates and two recent stamp size photograph.

**Candidates who fail to produce the requisite documents will not be admitted.**

## **7. Allocation of seats:**

Kindly refer the Notifications issued by Government of Punjab for all streams, available on the Board's website ([www.punjabteched.com](http://www.punjabteched.com) and [www.punjabteched.net](http://www.punjabteched.net))

## **8. Reservation:**

The Board shall make admissions to the affiliated institutes located in Punjab and the Union Territory of Chandigarh as per the reservation policy given by the respective Governments.

### **8.1. Reservation of Seats - Punjab**

The reservation of seats for institutes situated in Punjab (except CTR, Ludhiana, CIHT, Jalandhar) shall be as per Punjab Government, Department of Technical Education and Industrial Training Memo. No. 13/2/05-ITE2/469 dated 20th February, 2006.

A candidate shall be eligible to make claim for reservation under one reserved category only. However, the procedure for counselling/ allotment of courses and/ or institutes shall be such that if a candidate is getting a course/ institution higher in his/ her order of preference, as a general candidate, he/ she shall be so regarded, notwithstanding his/ her claim as a reserved category candidate. The seat under the reserved category shall then be offered to the candidates in that very reserved category.

Candidates opting for different reserved categories must upload the required certificates as proof at the time of Online Registration. The certificates must be in the format approved by the Government.

Certificate to be produced by a candidate belonging to Backward Class of Punjab in support of his/her claim under this category must not be dated earlier than one year before the first day of the counselling for admission. A certificate issued more than one year before the counselling date shall not be valid. All certificates for reserved categories must have been issued on or before the last date for verification of certificates by the institute.

As per amendment in Reservation policy Notification dated 12-04-2017, Governor of Punjab is pleased to increase the Reservation quota / percentage for Backward classes from 5% to 10% for admissions in educational, Technical and professional Institutions in the State of Punjab.

Reservation policy of Punjab/UT Government is not applicable for admission to Central Tool Room, Ludhiana & C.I.H.T. Jalandhar. The break-up of seats for this institution shall be as per the policy of Ministry of Industry, Government of India.

## **8.2. Reservation of seats – Chandigarh(UT)**

Reservation of seats for institutions located in the UT-Chandigarh will be as per guidelines issued by the Chandigarh Administration.

## **9. Admission Fees:**

The fee structure for all the institutions shall be as per policy issued by respective Governments (Government of Punjab and Chandigarh). The changes in fee structure, if any, for Punjab as well as Chandigarh will be notified through web sites at the time of admissions.

The security amount deposited by the candidates shall be refunded to them on successful completion of Diploma course by the concerned institution.

**Important Note:** The candidates are required to pay admission fees after getting Provisional Allotment from Board's counselling website. Admission fee can be submitted through online and offline mode of payment through student's portal.

## **10. Refund of Fees:**

In the event of a student/candidate surrendering the seat before starting of the course, the admission fee collected from the student after a deduction of the processing fee of not more than Rs. 1000/- shall be refunded. However if a student leaves after joining the course and the seat consequently falls vacant is filled by another candidate by the last date of admission, the fee shall be refunded after making proportionate deductions of fee and hostel rent (where applicable).

The request for refund of fee should be made to the Board within 3 months of the end of admission process preferably through online submission mode of the application in the counselling website (offline applications for the same shall also be considered –a student should submit one application whether online or offline). No applications will be entertained after the stipulated time.

## **11. TIME LIMIT FOR COMPLETION OF DIPLOMA COURSE:**

The maximum permissible time limit for completion of diploma course is twice the duration of the diploma course i.e. 6 years in case of 3-year Diploma course, 8 years in case of 4-year Diploma course etc.

## 12. FEE CONCESSION AND SCHOLARSHIP SCHEMES

Various fee concession and scholarship schemes are available to make Technical Education accessible to poor and meritorious students.

### 12.1. Full Fee Concession to SC candidates

Full fee concession is given to the candidates belonging to scheduled caste category, whose parents' annual income is less than Rs. 2.50 lakh.

### 12.2. Tuition Fee Waiver (TFW) Scheme

Five percent of the seats extra /additional in each of the institutes have been earmarked as seats under "Fee Waiver Scheme" in which total tuition fee of Rs. 22,000/- per year out of the total fee of Rs. 29,150/- will be waived off. The eligibility criteria for seeking admission under his category are:

- Pass in qualifying Examination.
- The parental annual income should not be more than Rs. 8 lacs
- The Waiver is limited to the Tuition Fee as approved by the State Level Fee Committee for Self-Financing Institutions and by the Government for the Government/ Government aided Institutions. All other Fees except Tuition Fee shall have to be paid by the beneficiary.
- These seats shall be filled only through online counselling as outlined in the prospectus.

### 12.3. Chief Minister Scholarship Scheme:

- This Scholarship Scheme is applicable only in the Government Institutions offering diploma courses.
- This scheme is available to students belonging to all categories. There is no limit of annual income.
- Under this scholarship scheme, tuition fee waiver is given to the students on the basis of %age of marks secured in the qualifying examination as under:

Diploma in Engineering, Diploma in Engineering (LEET), Diploma in MOP, Diploma in Pharmacy	60 % & above but less than 70%	70%

	90% & above	100%

**12.4.Fee Concessions given at Board Level**

- Scholarship for meritorious students, whose parents annual income is less than Rs. 2 lacs
- Full Fee concession of meritorious students, whose parents annual income is less than Rs. 1.5 lacs.
- Scholarship under discretionary quota of chairman for orphans, war widows and their wards, physically handicapped, having lost only bread winner of family.

**12.5. PM CARES for Children Scheme 2021**

PM CARES for Children Scheme has been launched by the Prime Minister for taking care of children who lost both parents during the COVID pandemic. Such children who are issued "PM CARES Certificate" shall be eligible for admission in Polytechnic Institutions under Supernumerary quota. They shall be eligible for SWANATH Scholarship. There shall be two supernumerary seats per course per institution.

**13. Other Important Note:-****13.1. Sikh minority quota**

As per Notification of Govt. of Punjab for session 2023-24, seats at Guru Nanak Dev Polytechnic College, Ludhiana and Baba Banda Singh Bahadur Polytechnic College, Fatehgarh Sahib have been reserved as Sikh Minority Quota. Candidates seeking admission in this quota must have passed the Sikh Religious Examination conducted by SGPC.

**13.2. Seats under management quota:**

One-third of the total seats available in the un-aided institutes have been marked as "Seats under management quota". The admission for the same shall be made at the level of the institute through online counselling. The candidate desirous of seeking admission under management quota shall also register on the Website for the purpose of allocation of the seat.

At the closure of second round of Online counselling, the vacant seats, if any, shall be filled at level of the institutes in the third round of counselling.

The Governor of Punjab is pleased to appoint the Punjab State Board of Technical Education & Industrial Training, Chandigarh (hereinafter the Board) as the authority competent to make admissions to THREE Year Diploma in Modern Office Practice for the academic session 2023-24. The Board shall recommend and authorize admissions to 3<sup>rd</sup> year of diploma in Modern Office Practice being run in all the Polytechnics/Institutions located in the State of Punjab and Union Territory, Chandigarh to which are affiliated with the Board and stand approved by the All India Council for Technical Education for the session 2023-24.

Admission to the Diploma Modern Office Practice course shall be made subject to grant of affiliation by the Punjab State Board of Technical Education & Industrial Training and approval by the AICTE Council of India.

**A. ELIGIBILITY FOR ADMISSION TO DIPLOMA IN MODERN OFFICE PRACTICE**

- I All those candidates who have passed the 10+2 examination with or without Science from a board recognized or established by Central/ State Government through legislation shall be eligible to apply for Three Years Diploma in Modern Office Practice.
- II Admission to Diploma in MOP course seats shall be made on the basis of relative merit in the qualifying examination mentioned above.
- III For the Academic session 2023-24, 85% seats shall be reserved for the internal candidates from within the State of Punjab and 15% shall be open to all candidates from outside Punjab, on all India basis.
- IV The Eligibility criteria for 85% seats shall be for candidates who are resident of Punjab State as per Punjab Government, Department of Personnel and Administrative Reforms (PP-II Branch) letter No. 1/3/95- 3PP11/9619 dated 6<sup>th</sup> June 1996 and letter No. 1/3/95-3PP11 /80 dated 1<sup>st</sup> January, 1999 or shall have passed the matriculation examination from an institution/school affiliated to Punjab School Education Board/ CBSE/ ICSE/ National Open School situated in Punjab. The candidate would be required to submit a domicile certificate to this effect from the Principal/Head of Institution last attended in the prescribed Proforma.
- V Apart from the basic educational qualifications prescribed above, the general eligibility criteria shall be as mentioned in Punjab Government, Department of Technical Education and Industrial Training Memo. No. 35/44/95-1T(2)/978



dated 21st March, 2003.

- VI The Punjab State Board of Technical Education and Industrial Training, Chandigarh shall follow a proper process for making such admissions.
- VII Admission of candidates, who fulfill all eligibility conditions, shall be made on the basis of the relative merit subject to reservation of seats, the detailed instructions in respect of which are given in Section B.
- VIII The students shall. pay the fees/ development fee and other charges both for the various seats, as per rates fixed by the Government of Punjab/Union Territory of Chandigarh or the Board.
- IX The fee structure for Foreign Nationals/Person of Indian origin shall be the same as for NRI candidates.
- X The guidelines for admission of Kashmiri migrants shall be as per Punjab Government in this regard. (Memo No. 8/21/II- ITE2/501423/1 dated 05.06.2015
- XI The guidelines for admission of Sikh minority community students to Guru Nanak Dev Polytechnic College, Ludhiana and Baba Banda Singh Bahadur Polytechnic College, Fatehgarh Sahib shall be as per Punjab Government Notification No. 18/33/2001-GC (6) 4513 dated Chandigarh, the 3<sup>rd</sup> April, 2001.
- XII The management quota shall be as per Punjab Govt. Departments of Technical Education and Industrial Training Memo no 13/129/2003-ITE2/1247 dated 25<sup>th</sup> April 2008, no,13/129/2003-1TE2/1892 dated 20<sup>th</sup> June 2008 and No.13/129/03-1TE2/171.dt.17<sup>th</sup> January 2011 as amended from time to time.
- XIII There shall be no bifurcation of the seats into "free seats" and "paid seats" This is in compliance with the judgment of the Hon'ble Supreme Court of India vide its judgment the case of T.M.A. Pai Foundation and other vs. State of Karnataka and others (2002) (8 SCC 481: AIR 2004 SC 355), and the instructions of Government of India, Ministry of Human Resource Development and the AICTE.
- XIV Academic session for newly admitted students may commence as per the academic schedule of All India Council for Technical Education, New Delhi for academic year 2023-24.
- XV State Government reserves its right to change any condition at any point of time.

**B) RESERVATION:**

- I. The reservation of seats shall be as per Punjab Government, Department of Technical Education and Industrial Training Memo. No. 13/2/05- 1TE2/1987 dated 2<sup>nd</sup> July, 2013 and Memo No. 8/41/2019-4TE2/53 dated 13<sup>th</sup> Sep, 2019. As regards the reservation of seats of Polytechnics under Union Territory, Chandigarh, the same shall be as per the policy intimated by the Chandigarh Administration to the Board.
- II. The attention of the applicants desirous of claiming reservation under any category whatsoever is especially drawn to the condition and stipulation that only the

certificates that have been issued on or before the last date of counseling shall only be accepted. The candidates are accordingly advised, in their own interest, to get the requisite certificates issued well before the cut-off date, otherwise their certificates shall not be considered and their claim for reservation shall be summarily rejected. No extension shall be granted in this regard, under any circumstances. The Governor of Punjab is pleased to appoint the Punjab State Board of Technical Education & Industrial Training, Chandigarh (hereinafter the Board) as the authority competent to make admissions in the 2<sup>nd</sup> year of Three-Year Diploma level Engineering & Technology Courses under LEET Scheme for the session 2023-24. The Board shall recommend and authorize admissions to 2<sup>nd</sup> year of diploma level Engineering & Technology Courses under LEET scheme being run in all the Polytechnics/Institutions located in the State of Punjab and Union Territory, Chandigarh to which are affiliated with the Board and stand approved by the All-India Council for Technical Education for the session 2023-24.

**A) ELIGIBILITY FOR ADMISSION FOR LATERAL ENTRY TO DIPLOMA ENGINEERING & TECHNOLOGY COURSES**

- I Candidates who have passed 10+2 Examination with Physics/ Mathematics/ Chemistry/ Computer Science/ Electronics/ Information Technology/ Biology/ Informatics Practice/ Biotechnology/ Technical Vocational subject/ Agriculture/ Engineering Graphics/ Business Studies/ Entrepreneurship (as per Approval hand book 2023-24) **OR**

10<sup>th</sup> along with 2 years ITI shall be eligible for admission to Second Year Diploma Courses of in any branch of Engineering and Technology, up to a maximum of 10% of sanctioned intake plus the unfilled vacancies of the First Year.

Vacant seats arising out of the students withdrawing the admission in the First Year shall also be considered for Lateral Entry.

- II In Case the seats remaining unfilled on the basis of eligibility criteria mentioned above, shall be filled on the basis of inter-se-merit of any of the following examination:
- (a) 10+2 Vocational examination in various branches from a board recognized or established by Central/State Government through a legislation.
- (b) Two years certificate course from Sant Longowal Institute of Engg. and Technology, Longowal.
- (c) Two years certificate course in skill Technician (Machinist), Skill Technician (Machine Maintenance) & Quality Assurance Inspector from R&D Centre for Bicycle & Sewing Machine, Ludhiana.
- (d) 3 Years AICTE approved Diploma in Engineering of any other branch from any recognized Board ( As per Punjab Govt. notification No. TECH-TE-2013/5/2021-4TE2/1061 dated 28-10-2021)

- III Admission to LEET seats shall be made on the basis of relative merit in the qualifying examination mentioned above.

- IV For the Academic session 2023-24, 85% seats shall be reserved for the internal candidates from within the State of Punjab and 15% shall be open to all candidates from outside Punjab, on all India basis.
- V The Eligibility criteria for 85% seats shall be for candidates who are resident of Punjab State as per Punjab Government, Department of Personnel and Administrative Reforms (PP-II Branch) letter No. I/3/95-3PPII/96I9dated 6<sup>th</sup> June 1996 and letter No. I/3/95-3PPII /80 dated 1<sup>st</sup> January, 1999 or shall have passed the matriculation examination from an institution/school affiliated to Punjab School Education Board/ CBSE/ ICSE/ National Open School situated in Punjab. The candidate would be required to submit a domicile certificate to this effect from the Principal/Head of Institution last attended in the prescribed Proforma.
- VI. Apart from the basic educational qualifications prescribed above, the general eligibility criteria shall be as mentioned in Punjab Government, Department of Technical Education and Industrial Training Memo. No. 35/44/95-1T(2)/978 dated 21st March, 2003.
- VII. The Punjab State Board of Technical Education and Industrial Training, Chandigarh shall follow a proper process for making such admissions.
- VIII. Admission of candidates, who fulfill all eligibility conditions, shall be made on the basis of the relative merit subject to reservation of seats, the detailed instructions in respect of which are given in Section B.
- IX. The students shall. pay the fees/ development fee and other charges both for the various seats, as per rates fixed by the Government of Punjab/Union Territory of Chandigarh or the Board.
- X. The fee structure for Foreign Nationals/Person of Indian origin shall be the same as for NRI candidates.
- XI. The guidelines for admission of Kashmiri migrants shall be as per Punjab Government in this regard. (Memo No. 8/21/II- ITE2/501423/1 dated 05.06.2015
- XII. The guidelines for admission of Sikh minority community students to Guru Nanak Dev Polytechnic College, Ludhiana and Baba Banda Singh Bahadur Polytechnic College, Fatehgarh Sahib shall be as per Punjab Government Notification No. 18/33/2001-GC (6) 4513 dated Chandigarh, the 3<sup>rd</sup> April, 2001.
- XIII. The management quota shall be as per Punjab Govt. Departments of Technical Education and Industrial Training Memo no 13/129/2003- ITE2/1247 dated 25<sup>th</sup> April 2008, .no,13/129/2003-1TE2/1892 dated 20<sup>th</sup> June 2008 and No.13/129/03-1TE2/17I.dt.17<sup>th</sup> January 2011 as amended from time to time.
- XIV. There shall be no bifurcation of the seats into "free seats" and "paid seats" This is in compliance with the judgment of the Hon'ble Supreme Court of India vide its judgment the case of T.M.A. Pai Foundation and other vs. State of Karnataka and others (2002) (8 SCC 481: AIR 2004 SC 355), and the instructions of



Government of India, Ministry of Human Resource Development and the AICTE.

- XV. Academic session for newly admitted students may commence as per the academic schedule of All India Council for Technical Education, New Delhi for academic year 2023-24.
- XVI. State Government reserves its right to change any condition at any point of time.

**B) RESERVATION:**

- I. The reservation of seats shall be as per Punjab Government, Department of Technical Education and Industrial Training Memo. No. 13/2/05-1TE2/1987 dated 2<sup>nd</sup> July, 2013 and Memo No. 8/41/2019- 4TE2/53 dated 13<sup>th</sup> Sep, 2019. As regards the reservation of seats of Polytechnics under Union Territory, Chandigarh, the same shall be as per the policy intimated by the Chandigarh Administration to the Board.
- II. The attention of the applicants desirous of claiming reservation under any category whatsoever is especially drawn to the condition and stipulation that only the certificates that have been issued on or before the last date of counseling shall only be accepted. The candidates are accordingly advised, in their own interest, to get the requisite certificates issued well before the cut- off date, otherwise their certificates shall not be considered and their claim for reservation shall be summarily rejected. No extension shall be granted in this regard, under any circumstances. This provision should be given wide publicity and also included conspicuously in the prospectus-cum-information brochure to be issued by the Board.
- III. The Board shall make a provision in the Online Admission application form for the candidates to indicate the category, if any, under which they are seeking reservation. In case of no reservation is claimed in the application form, candidate shall be treated as general category. The Government of Punjab may also set up a Committee to effect inter se gradation of candidates claiming reservation under certain categories, as indicated in the aforesaid memo dated 2<sup>nd</sup> July, 2013. In the absence of this Committee, the Board shall effect this inter se gradation, in accordance with the criteria laid down in the aforesaid memo dated 2<sup>nd</sup> July, 2013.
- IV. A candidate shall be eligible to make claim for reservation under one reserved category only. However, the procedure for counseling/ allotment of courses and/ or institutes shall be such that if a candidate is getting a course/ institution higher in his/ her order of preference, as a general candidate, he/ she shall be so regarded, notwithstanding his/ her claim as a reserved category candidate. The seat under the reserved category shall then be offered to the candidates in that very reserved category.
- V. The unfilled seat in any reserved category shall be merged in the General Category quota after all eligible candidates of the reserved categories have been called for counseling.

**C) ONLINE- COUNSELING**

- I. For admission to Lateral Entry Diploma Courses web based online counseling shall be followed for the Academic year 2023-24 and therefore physical presence of candidates for the counseling will not be necessary.
- II. During the online counseling, candidate shall be given opportunity to exercise choice of institutes / trade in centralized counseling and thereafter the vacant

seats, if any, shall be filled by the institute on the criteria of admissions under vacant seats/management quota. It is categorically laid down that vacant seats are not being transferred as management quota seats. Only criteria as laid down for admission under management quota should remain applicable to fill such vacant seats.

- III. The Board shall give a public notice in leading newspapers and media regarding the schedule of counseling.
- IV. While fixing the date of counseling for admissions, the Board shall keep in view the cutoff date and schedule for approval by All India Council for Technical Education for the academic session 2023-24.
- V. There shall be two rounds of centralized counseling by State Board of Technical Education, Punjab Chandigarh. The schedule and Deadline of counseling will be as per Academic Calendar issued by AICTE for the academic session 2023-24 and strictly as per orders of honorable Supreme Court.

**D) ADMISSION SCHEDULE**

The last date, up to which students can be admitted against vacancies will be as per academic calendar issued by AICTE for the academic session 2023-24 and strictly as per orders of honorable Supreme Court.
